#### **Compliance Status**

This website is partially compliant with the <u>Web Content Accessibility Guidelines version</u> 2.1 AA standard, due to the following issues:

#### Non-compliance with the accessibility regulations

- Page language has not been identified Missing language tags mean that screen readers will revert to their default pronunciation settings. They can result in a strange or confusing experience for users who access content in more than one language. This fails WCAG 2.1 success criterion 3.1.1 (Language of Page).
- Image without a text alternative Images on some pages do not always have suitable image descriptions. Users of assistive technologies may not have access to information conveyed in images. This fails WCAG 2.1 success criterion 1.1.1 (Non-text Content).
- Link without a text alternative Some links do not provide a text alternative. This can be problematic for users who are blind or have low vision and it fails WCAG 2.1 success criteria 2.4.4 (Link Purpose: In Context) and 4.1.2 (Name, Role, Value).
- Text not included in an ARIA landmark Some content may be hard to navigate or identify because it is incorrectly structured without landmarks. This fails WCAG 2.1 WAI-ARIA authoring practices.
- 5. Page has no headings Some pages do not have any heading tags. This can make it hard for assistive technology users to understand how content in structured and for screen readers to navigate content. This fails WCAG 2.1 accessibility best practices.
